### SUPPLEMENTARY REGULATIONS

#### About The Event

This event is intended to act as an introduction for adult & junior competitors to low level Motorsport activity. The event will consist of two elements:

1. A briefing element of approx. 30-40 minutes providing an overview of the Pakenham Auto Club activities and rules along with the C.A.M.S. requirements and regulations. The club holds an expectation that parents/guardians will also attend this session.
2. A participation element consisting of one on one observation and instruction in motorkhana driving with an experienced club member, of approximately 1-2 hours duration.
3. The event will be held under the International Sporting Code of the FIA, the National Competition Rules (NCR) of the Confederation of Australian Motor Sport Ltd. (CAMS), the National Motorkhana Code, the CAMS Guidelines for Passengers in Vehicles, the CAMS Come & Try Policy, these Supplementary Regulations and any Further Regulations that may be issued.

11. Entries are open to persons 12 years of age or over. The maximum number of entries that will be accepted is 20. Entries will be accepted in order of receipt. The Promoter reserves the right to refuse entries in accordance with NCR83.
12. All participants must read the disclaimer then complete and sign the Entry form. All drivers must hold a CAMS Level 1 licence or superior. .
13. As the event is non competitive, there will be no results published or awards presented.

15. Vehicles: Suitable vehicles will be provided by the Pakenham Auto Club.
16. General
  - Adequate footwear shall be worn while competing. Bare feet, thongs or sandals are not permitted. Seat belts must be worn at all times whilst in the vehicle. All driver apparel shall be in accordance with Schedule D of the CAMS Manual.
  - Passengers/Instructors must hold a current civil drivers licence or suitable CAMS licence and must sign the relevant disclaimer before participating in the event.
  - All vehicles must comply with Group 4H of the NCR and Schedule A of the General Requirements for Cars & Drivers.
  - Insurance shall be in accordance with Appendix I of the CAMS Manual
  - The organisers reserve the right to abandon, postpone or cancel the event in accordance with NCR 59.
  - Each vehicle shall, of necessity, be configured such that the sound emitted when measured 30m from the track edge does not exceed 95dB(A).
  - During any event, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under the control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate. Refer NCR 145A of the Current CAMS Manual. In addition, the persons concerned will be subject to the Articles of the Standard Operating Procedure for Alcohol Testing and CAMS Anti-Doping Policy. Competitors, crews or officials may be randomly tested for alcohol by a CAMS Accredited Testing Official (CATO) or other drugs at any time during the event(s). The CAMS Anti Doping Policy, as appears in the CAMS Manual of Motor Sport and as amended from time to time, is recognised as an integral component of the NCR and is duly authorised as such. In any areas where the National Competition Rules and the CAMS Anti Doping Policy conflict, the CAMS Anti Doping Policy will take precedence.
