(CAMS), the National Motorkhana Code (NMC), Group5 Motorkhana Series Regulations, the CAMS Guidelines for Passengers in Vehicles, these Supplementary Regulations and any further regulations that may be issued. ## ENTRIES

The entry fees will be as follows:

**Full event** (G5 motorkhana & Spit Roast) - \$30 per driver or \$23 per junior driver.

**G5 motorkhana only** - \$15 per driver or \$10 per junior driver.

**Spit Roast only** - \$15 per additional person (*\$8 per child 6 - 12yo, under 6yo - free*)

**NOTE** – Entries including the spit roast need to be received before 5pm Thursday 21<sup>st</sup> May to ensure that you are being catered for .....

Entries should be sent c/o Entries Secretary - 34 Piperita Road, Ferntree Gully 3156 (Tel 0412 175518). Personal accident insurance is included. Entries must be made on the official entry form. Entries open on printing of these regulations and close at the start of competition on Saturday 16th April 2011. Cheques and Money Orders should be made payable to the Ford Four Car Club. The organisers reserve the right to refuse an entry in accordance with NCR 83. A maximum of 80 entries will be allowed, accepted in order of receipt of payment and completed forms.

## DRIVERS

All drivers must hold a CAMS Level 2NS License (which *may* be available for purchase on the day, but drivers should try to acquire a license from their club beforehand) and be a current member of a car club affiliated with CAMS in Victoria. Drivers in vehicles with no windscreen must wear adequate eye protection when participating. Drivers of vehicles classified as specials, must wear a helmet, which complies with AS1698 and carries markings to that effect or otherwise of a standard as listed in the 2011 CAMS Manual and appropriately marked to that effect and deemed by scrutineers to be in a suitable condition for motorsport use. Adequate footwear must be worn by all drivers whilst participating (i.e. no bare feet or thongs). Refer Schedule D for all Apparel requirements.

## PASSENGERS

A single passenger may be carried by competitors during competitors competing providing they are properly restrained and seated appropriately, complying with Article 19 of the National Motorkhana Code and the CAMS Guidelines for Passengers in Vehicles. All passengers must be older than 12 years of age, and have signed the passenger indemnity form (or be another competitor).

## LIMITATIONS

The organizers reserve the right to alter, postpone, or abandon the event if there is extreme rain in the area, at Total Fire Ban or insufficient entries prior to the event. Phone: 9758 4208AH (Answering Machine) between 18:00 and 21:00 hrs on Friday 15<sup>th</sup> April 2011 if in doubt. Abandonment, postponement and cancellation will be in accordance with NCR 59.

## VEHICLES

Vehicles must comply with Schedule A of the 2011 CAMS Manual and the rules for Group 4H Motorkhana cars. Non production and Moke type vehicles must be fitted with an approved seat belt and roll bar. Appropriate mufflers must be fitted to all vehicles to comply with noise restrictions.

Vehicles not complying with the requirements of the class(s) they have entered for will be reclassified into the correct class during collation of the results.

**NOTE** – All vehicles competing after dark will need a front and a rear marker light that will be switched on when the vehicle is in operation after dark. These front and rear marker lights may consist of bicycle lamps or glow sticks as a minimum, but must be white in color on the front of the vehicle and red / amber at the rear of the vehicle. Lighting on the test area will not be available and vehicle lighting is strongly advised.

SCRUTINY	Scrutiny for the event will commence at 1pm and all competing vehicles must pass scrutiny prior to competition. Competitors must present their license, club membership and logbook (if applicable) to the scrutineers.
TESTS	<p>A Driver Briefing will be held at 3:30pm. It is anticipated that a minimum of 4 and a maximum of 10 tests constituting the event. Test dimensions may be varied from the specified minimum dimensions as shown.</p> <p>Tests undertaken after dark will be marked with colored glow sticks on the poles to signify the colored flags. It is also anticipated that some flood lighting will be provided in the pit area to give some lighting to the pits after dark.</p> <p>Vehicles will commence stationary, within the start garage in a forward facing direction and finish by entering the garage in a forward direction, between the two front (red) markers and come to complete halt.</p>
TIMING	Timing will be by hand held stop watches. Timekeepers will be Judges of Fact as specified in the NMC clauses 17.2 & 17.3. Results shall be determined by the lowest aggregate of elapsed times on the tests completed, plus any penalties.
PENALTIES	Penalties will be applied as per NMC and Group5 Motorkhana Series Regulations. Each flag requiring rectification will result in a 5 second penalty being added to the time for that run. Protests must be lodged in accordance with Part XII of the current CAMS Manual.
EXCLUSIONS	A driver may be excluded from the event (or part of the event) at the director (or steward's) discretion for dangerous driving, either on or off the test area(s). In accordance with NCR145a, any participant taking or under the influence of alcohol or drugs during the event will be excluded and may be subject to further action.
CLASSES	<p>Cars will be grouped into classes as follows (Group5 Motorkhana Classes)</p> <p><b>A</b> – Vehicles up to 4.25m in length, engine over drive.</p> <p><b>B</b> - Vehicles up to 4.25m in length, engine away from drive</p> <p><b>C</b> - Vehicles over 4.25m in length, engine over drive.</p> <p><b>D</b> - Vehicles over 4.25m in length, engine away from drive</p> <p><b>E</b> – Specials - significantly lightened vehicles or vehicles fitted with fiddle brakes or with a foot brake operating the rear wheels only.</p> <p><b>J</b> – Juniors under 18years of age with handicap factors applicable to car class.</p>
AWARDS	Awards will be made in accordance with Group 5 Regulations.
GENERAL	<p>Insurance will be provided as per Appendix I of the CAMS Manual.</p> <p>Fuel will not be provided at the venue. Fuel must comply with Schedule G of the current CAMS Manual.</p>
